SUMMARY NOTE ON THE CONTROVERSY / LEGAL MATTERS RELATED SUPPLY OF CATTLE FEED TO MAHARASHTRA DURING THE DROUGHT IN 2013.

An act of philanthropy by the Chairman, GCMMF, in response to requests received from the Maharashtra State Cooperative Dairy Federation (Mahanand), with a personal request by the Union Agriculture Minister to the then Chairman of GCMMF, has been blown out of proportion. When already a PIL is pending on the matter, on an FIR filed by the District Registrar of Cooperatives, two of our senior-most officials (MD and CGM) have been taken into police / judicial custody. While the CGM was arrested on our Republic Day, the MD was picked up from his residence in Ahmedabad after midnight at 2.10 A.M. (on 27th night), but officially showing in police records as 4.00 P.M. on 28th Jan !

The following documents will prove, unequivocally, that the supply of cattle feed was genuine (on account of severe drought), and we had followed all normal transactional procedures:

- 4. 29/4/2013 Board Resolution of Dudhsagar Dairy, authorizing the MD of Dudhsagar Dairy for the needful in the above request for cattle feed.
- 5. 12/8/2013 Debit Note of Rs.22.5 crorres for 13731.5 MT of cattle feed issued to GCMMF
- 6. Dispatch details of cattle feed to various centres in Maharashtra
- 7. 10/10/2013 Certificate of Receipt of cattle feed, with abstract, from Mahanand
- 8. 23/10/2013 Letter from MD, GCMMF, addressed to MD, Dudhsagar returning the Debit Note.
- 9. 28/10/2013 Letter from MD, Mehsana Union to CGM, Mehsana Union asking him to send the Debit Note on Mahanand Dairy immediately.
- 10. 29/10/2013 Internal Note from CGM, Mehsana Union to Dy.Manager (Sales-CF)
- 11. 29/10/2013 Debit Note on Mahanand Dairy prepared
- 12. 30/10/2013 Debit Note on Mahanand Dairy forwarded to MD, Mahanand.
- 13. 27/01/2014 Board Resolution of Dudhsagar Dairy regarding the cattle feed supplied
- 14. 30/01/2014 Reminder letter to MD, Mahanand Dairy regarding the Debit Note.

Despite providing all the above documents, the police have still not released our Officers arrested. Is it just and fair? Can an act of philanthropy be termed as 'criminal' act ?
