Annexure-1: Eligibility Criteria

2. Technical Eligibility

The bidder must meet the following minimum qualification criteria;

- 2.1 **Experience:** Bidder in the same name and style should be in the similar business for at least 5 financial years. In case of change of name of bidder by merger / acquisition / change in status, the bidder has to submit documentary evidences. Bidder has to upload and submit copy of purchase orders as well as order execution document or work completion certificate. Upload a PO copy which is 5 years old for this purpose.
- 2.2 **PO Copy:** Bidder must have Supplied & Installed minimum 5 nos. Mypro Touch Panels of similar type in his own name in any Industries/Co-operative Dairy or Govt. department of India within last 5 years. Your Supplied & Installed Mypro Touch Panels should have communication with Scada and PLC.
 - Bidder has to upload and submit copy of purchase orders as well as order execution document or work completion certificate.
 - Purchaser may visit site of execution. Bidder shall facilitate visit of the plant where said executions of Unit is carried out.
- 2.3 Bidder should be the original manufacturer or authorized dealer/distributor for the quoted make and item. Bidder has to provide either
 - (1) Self-declaration of being original Manufacturer

- or
- (2) Authorization certificate of dealership/distributorship issued by original Manufacturer

8.1 Jurisdiction

Settlement of any dispute out of the Purchase Order / Contract against this Bid shall be subject to the courts at Jurisdiction Mehsana, Gujarat only.

8.2 Price Basis

Price charged by the supplier for goods delivered and services performed under the contract shall not vary from the prices quoted by the supplier in its bid and the contract shall be on fixed price basis.

- Free delivery at site including loading and unloading.
- The Price specified should be inclusive of duties,
- Packing and forwarding,
- GST wherever applicable,
- Transit insurance and freight (FOR site)
- Storage, Erection and Commissioning, if applicable as per tender terms
- Training to users , if applicable as per tender terms
- Warranty as specified in tender

8.3 Bid Evaluation

The price bid will be evaluated together for all items. Purchaser will award contract for any option at its sole discretion without assigning any reason.

8.4 Delivery and Documents

All the delivery of the goods should accompany with Original and three copies of:

- The supplier's invoice showing Purchase Order No., Goods Description, Quantity, Unit price, Total amount etc.
- Delivery note / Packing list
- Lorry receipt.
- Manufacturer's / Supplier's Warranty Certificate, where ever applicable
- Inspection Certificate issued by the Nominated Inspection Agency, and Supplier's Factory inspection Report
- Certificate of origin (for imported items).
- E-Way Bills, where ever applicable
- Any other document evidencing payment of statutory levies.

8.5 Variation in Order Quantity

The order quantity may vary up to 10%, while finalizing the order and / or while execution of the complete order.

8.6 Warranty / Guarantee

The supplier warrants that the goods and equipment supplied, installed and commissioned under the contract are new, unused, of most recent or current models and incorporate all recent improvements in design and materials unless provided otherwise in the contract.



The supplier further warrants that the goods supplied under this contract shall have no defect arising from design, materials or workmanship (except in so far as the design or material is required by the purchaser's specifications) or from any act or omission of the supplier, that may develop under normal use of the supplied goods in the normal conditions.

The supplier also has to guarantee that the goods supplied shall perform satisfactorily as per the designed / rated / installed capacity as provided for in the contract. The warranty will not cover normal wear and tear of consumables; however the electrical parts will be covered under warranty.

The purchaser shall promptly notify the supplier in writing of any claims arising under this warranty.

Upon receipt of such notice, within 48 hours, the supplier shall, with all reasonable speed, repair or replace the defective goods or parts thereof, without cost to the purchaser.

If the supplier, having been notified, fails to remedy the defect (s) within a reasonable period, the purchaser may proceed to take such remedial action as may be necessary, at the supplier's risk and expense and without any prejudice to any other rights which the purchaser may have against the supplier under the contract.

This warrantee / guarantee shall not cover any damage/s resulting from normal wear and tear or improper handling by the purchaser or his authorized representatives.
