This is a two-stage tender. First technical data submitted by bidders will get analysed at our end. Then commercial bid of only technically qualified bidders will be considered for second stage of commercial evaluation. Only after verification and acceptance of documents submitted, commercial bid will get opened.

1. Downloading of Tender Document

Tender document can be downloaded from website www.dudhsagardairy.coop/tenders . Any updates, corrigendum, date extension etc. related to this tender will get published on www.dudhsagardairy.coop/tenders only.

2. Submission of Tender

2.1 Submission of the Tender Fee & EMD details

Bidder has to submit payment details of tender fee and EMD in separate envelope.

2.2 Submission of Other Supporting Documents

All other supporting documents asked has to be submitted with proper name of documents for easy identification and at proper stages mentioned in the offline tender form. Bidder should submit only relevant document and no any unnecessary document. Submitting unnecessary document may lead to disqualification.

2.3 Hard Copy Documents Submission

All the documents asked in the tender have to be submitted in Hard Copy only with proper indexing and page numbering. All eligibility criteria documents must be kept in a separate envelope marked 'Eligibility Criteria Documents'

2.4 Submission of Commercial (Price) Bid

Bidder should submit Commercial (Price) Bid in physical form in a separate envelope marked 'Price Bid Documents'.

Note: Only after verification and acceptance of documents submitted, commercial bid will get opened.

If EMD amount is more than Rs. 10 lakhs then it can be paid in Bank Guarantee (BG) also. The bank guarantee issued by a Nationalised Indian Bank/other major banks like HDFC Bank, ICICI Bank, Axis Bank, IDBI Bank. Bank Guarantee from a foreign bank having branch in India may be accepted.

ANY OTHER MODE OF PAYMENT IS NOT ACCEPTABLE

After Paying the amount by NEFT/RTGS/IMPS/BG, details of the same should be given in preliminary stage of the tender document submission. The payment advice of the transaction to be submitted in hard copy as a proof of payment.

Bidder has to submit original BG along with technical documents if EMD is paid in BG.

In case of re-tender of a tender, bidder who had participated in the original tender can submit tender fee and EMD details of original tender in re-tender.

Kindly note that tender fee is not refundable in any case even in case bidder is not able to submit tender completely.

4. Earnest Money Deposit (EMD)

All Bids must be accompanied by Earnest Money Deposit (EMD) in the form specified in the Bidding document. The Bids not accompanied with EMD shall be summarily rejected. The Bid security shall be denominated in Indian Rupees of value as specified.

The security deposit/EMD will be interest free.

EMD of unsuccessful bidders will be refunded after completion of our tender and purchase order process. EMD of successful bidder will be returned only after successful execution of Purchase order/contract.

5. Performance Security

7. Tender Date Extension Request

Bidder must request through email for any extension needed at least three days (72 Hours) prior to the last date of tender. The extension request must be accompanied with the payment receipt of Tender Fee and EMD. Without Tender fee, EMD and any request after 72 Hours to close the tender will not be entertained in any condition.

8. Rights Reserved by Dudhsagar Dairy, Mehsana

Dudhsagar Dairy, Mehsana, at its sole discretion and without assigning any reason thereof, reserves the right to accept and / or reject the whole or part of any or all the Bids received at any stage of tender. Similarly, we reserve the right to award Purchase order in full or part items/ quantity to any bidder. Dudhsagar Dairy reserves the right to re-conduct auction/negotiation starting from previously closed rates.

In case of dispute, decision taken by I/C Managing Director will be final.

2. Specific terms of supply and scope of work

2.1 Earnest Money Deposit (EMD)

1. The EMD of unsuccessful bidders shall be returned in 30 days from finalization of Sales Order of successful Bidder.

2. The EMD amount of successful bidders will be retained by the MDCMPUL till the completion of the total deal of tender. It will be adjusted against the final bill of eligible bidder or may be returned to the unsuccessful bidder, as the case may be. This EMD shall be refunded after successful completion of contract.
3. No interest shall be paid by MDCMPUL on the Earnest Money Deposit amount.

2.2 Forfeiture of Earnest Money Deposit (EMD) and Penalty

1. Further in case during contract period, selected bidder/buyer fail to execute contract obligation and if situation arise to compel us to sell offered old vehicles to any other party at lower rate, then the difference in selling amount and appropriate penalty will be recovered from the bidder/buyer or the equivalent amount will be adjusted from the EMD of the original bidder/buyer. This does not in any way effect the right of the MDCMPUL to forfeit EMD as provided herein. The communication of Store I/C is final and shall be binding to the bidder/buyer. The bidder/buyer whose order is terminated shall have no right to claim for any compensation whatsoever reason. In such cases the bidder/buyer will be **BLACKLISTED** for a period as may be decided by the MDCMPUL.
2. If the bidder/buyer or its representative is found to be involving in unethical practice like and/or involved in any kind of theft or doing any malpractice or try any unfair business practice with our employee/s or any other decision-making person/s of the Union or with security personnel and is against the rules and regulation of the organization, with or without documentary evidence as a proof, such action shall be considered as a breach of the Sales Order. In such case, at the discretion of the MDCMPUL Sales Order shall be liable for cancellation and EMD will be forfeited. Further, bidder/buyer will be **BLACKLISTED** for a period as may be decided by the MDCMPUL.
3. If the successful bidder/buyer at any stage either neglects or refuses or is unable to take delivery of the Old Vehicles for any reasons whatsoever and/ or the performance of the bidder/buyer is unsatisfactory, then MDCMPUL will have the right to terminate the Sales Order and buyer. Further, at the sole discretion, MDCMPUL shall enforce forfeiture of bidder's/buyer's EMD and claim such further losses and damages that may be caused to the MDCMPUL. In such cases the bidder/buyer will be **BLACKLISTED** for a period as may be decided by the MDCMPUL.

3. Scope of Work

1. The Old Vehicles shall be made available to the bidder/buyer at approved rate only.

2. The loading & transportation of the Old Vehicles is in the scope of the bidder/buyer.
3. If any Old Vehicles is to dismantle and lifted from its existing place, all care is to be taken by the party to avoid any damage to property of the Union and any person. In case of any damage to the property of union or any person, the bidder will be responsible to compensate the cost/claim before delivery of awarded items.
4. Charges towards any such damage of the equipment / material caused due to negligence / mishandling by bidder's/buyer's workers shall be deducted along with appropriate penalty and shall be recovered from bidder/ buyer's EMD after assessment of loss by our Engineer In charge. The assessments of Dudhsagar Dairy shall be final & binding to the bidder/buyer.
5. As on date all captioned old Vehicles are in running condition and are under usage by MDCMPUL, but are Sold on "AS IS WHERE BASIS, WHAT IS BASIS'. No Complaint/ Claim will be entertained for the condition of captioned vehicle.

4. Rules & Regulations

1. During course of lifting Old Vehicles, bidder/buyer shall be fully responsible for safety of his workers, equipment and MDCMPUL premises and shall abide by safety rules prescribed by the Government.
2. MDCMPUL will in no way be responsible for any accident, damage or injury to the contractor's workmen or equipment while in factory premises.
3. We are in the process of production of Milk and Milk products therefore it is strictly prohibited to smoke or chew tobacco or Gutka in Dudhsagar Dairy premises. If any of your representative found doing the same in the premises. Then penalty will be charged as per rules and regulation of the organization.

7. Other Terms & Conditions

1. All liabilities towards the said Tender Old Vehicles shall cease as soon as issue of Sales Order by MDCMPUL and subsequent acceptance of the same by the successful bidder/buyer. MDCMPUL shall not be responsible for any breakage, shortage or damage to these Old Vehicles or its parts thereafter. The Old Vehicles shall be kept solely at the risk and cost of the successful bidder/buyer.
2. Bidder/ buyer shall have to lift all offered Old Vehicles of Sales Order within 30 days from the issue of Sales Order. Extension may be granted at the discretion of MDCMPUL management.
3. The possession of Old Vehicles shall be handed over by MDCMPUL to the bidder or to his authorised representative, who shall produce original Money Receipt issued by MDCMPUL for the payment made by the bidder along with Authorised Letter from bidder. Without Authority Letter, Subcontractor of original bidder will not be allowed to take delivery of the awarded Old Vehicles.
4. Bidder/buyer shall load allotted Old Vehicles only as mentioned in Sales Order. Any dispute arising in this regard at Security Gate will be sole responsibility of bidder/buyer.
