AMC of Electornic Weighing scales of Patan-DSD, Kadi- DSD/Harij CC/Kheralu CC//ViharC Centers:

Terms & Conditions for AMC of Electronic weigh scale.

- (1). Annual Government stamping and re-verification from legal metrology must be cleared by you for all here mentioned scales, Only necessary Government stamping fees towards stamping shall be made extra at actual on introduction of CHALAN copy.
- (2). Quarterly thorough service along with the calibration of all the scales will have to be carried out and calibration cum service certificate will have to be provided to the user section in charge that must be witnessed by respective maintenance in Charge of Centers.
- (3). For any kind of Breakdowns during the AMC duration, Your technician will have to report to maintenance In Charge of Centers, prior to attending any complaint to witness the service / maintenance.
- (4). Original brand spare parts (PCB, Feather Key, All electronics components, Load Cell etc)those needs replacement will have to be arranged by you how ever the permission/confirmation for the replacement of parts will have to be obtained from maintenance In Charge of Centers. The payment towards replaced parts will be made after introduction of bill.
- (5). Damaged Spare parts replaced at your works or at site will have to be submitted to the maintenance In Charge of Centers.
- (6). You will have to report complaining section within five hours from the receiving of maintenance call, you will be sole responsible for the loss occurred due to delay in maintenance and / or wrong calibration of measuring scale or service of weighing scale and the sum of loss shall be deducted from the payment amount towards the penalty if any.
- (7). If any weighing scale will be obsolete during this AMC, it will not be applicable for service charges from that obsolete date or in forth coming quarter.
- (8). The AMC payment will be released in four division's i.e at the End of every quarter after receiving preventive service reports of each weighing scale per each quarter.
- (9). The AMC validity will be effective from date of P.O.Submission.
- (10). The supplier has to quote rates separately with ARC quotation for all standard make components to be required for maintenance i.e PCB, Feather key, Transformer, Potentiometer, Supply cord, LED, Load Cell etc.
