The buyer, who will default on delivery, necessary deduction will be made as per tender terms and conditions and may be barred from participating in any future cattle feed scrap tender for persistent default.

Settlement of any dispute out of the Sales Order / Contract against this Bid shall be subject to the courts at Jurisdiction Mehsana, Gujarat only.
